Narrative Text Report # 1

On this date, I was working in an undercover capacity monitoring a protest called "March for Justice for Ron Ronquillo" that began at Barnum park. The group of demonstrators numbered approximately 40 to 50 participants as they began to march. They were shouting phrases such as "fuck the police" and the like. They took to the streets and blocked egress of motor vehicles from Federal and 6th Avenue until the termination of the march at or near 16th and Curtis Street. During the march I walked alongside the participants and was vigilant for any criminal behavior such as damage to property or injury to persons. I observed one of the participants was carrying a battered wooden 2 by 4 in his hand. He was described only by his clothing as his face was covered. He was wearing black or dark blue pants, a black hoodie sweatshirt with the hood up, a black mask, black gloves, and dark sunglasses. The hoodie had an identifiable blue trim around the front fringe. I communicated this to the command post for officer safety. I was also aware such an implement could be used to injure others and cause damage to property.

In the 1400 block of Delaware as we were nearing Colfax Avenue I observed the described party quickly approach a marked U.S. Mint police SUV. He raised his arms up with 2 by 4 in hand and violently swung down at the front passenger window of the vehicle. He then moved to the back end of the vehicle and swung again at the rear passenger quarter panel. He quickly moved away and looked back to I believe see if he was detected by police officers down the street. He then turned and proceeded north towards Colfax Avenue. I communicated what I had just observed to the command post. The described person was often turning his head back in what I believe was to see if he had been detected. As we crossed Colfax and entered the 1400 block of Tremont Street I took a picture of him from behind carrying the 2 by 4. I sent this to the command post for further identification purposes. As we crossed 15th Street on Tremont I observed the described party with the 2 by 4 throw it into

the bed of a white older model pickup truck (Co. Lic. plate 252 FJO). He then continued toward 16th Street. I communicated this to the command post but gave out our street location as Court not Tremont. I continued surveillance on the party down the 16th street Mall. He appeared more comfortable because he began to drag a flower pot from the median into northbound traffic to hinder traffic. I then watched another participant run up and attempt to break a plate glass window in the 600 block 16th street. He joined up with my described party and they appeared to celebrate his actions with shouts of approval and slapping of hands. That party was also in all black and his face was covered. He was taller than the one that I was observing. They continued to walk together down the mall. In the 900 block of 16th street, I observed several of the protest participants move orange barricade barrels and caution tape into the street to hinder vehicular traffic. The party that I continued to watch was also a participant.

At 16th Street and Curtis Street while watching the party who did the damage to the government vehicle I observed several marked police vehicles approach they disembarked and went right to the party I had described and communicated to the command post. I observed them take him to the ground and with some effort placed him in custody. I immediately communicated to the command post that they had the person I had described was in custody. He was transported from the scene in a police vehicle. I went back to where I had observed him throw the 2 by 4. I saw the truck with the plate I had stated parked in the same position. I looked in the bed and saw the 2 by 4. I took pictures of the board in the bed, the license plate of the truck and the general location it was parked. I took the board to property and booked it into evidence.
